- 1). **Meeting Call to Order:** Lake calls the meeting to order at 6:00 PM.
- 2). **Approval of Minutes:** Lake reports that minutes are pending hire of new Administrative Assistant, the meeting has been recorded on BCTV until transcribed.
- 3). **Additions and Deletions:** Correspondence WSWM Workshop
- 4). **Members of the Public:**
  - A). **Townshend Historical Society Presentation:** Charlie Marchant and Lee Petty give report concerning two projects being coordinating by the THS;
    1. **The Stone Arch Bridges Project:** THS has applied for additional funds from the State of Vermont. If awarded the funds it would be through a matching grant. THS is requesting that the Town to commit additional funds to match the state funds. There is discussion on the increased cost of the project and putting it out to bid. THS expresses their concern that this is a restoration project not a repair project which limits the number of people qualified to perform the work. Lake recommends doing further research on why the increased costs and get back to the Selectboard on the matter.
    2. **Pathway Project:** Charlie Marchant gives the report: THS is looking into creating a bike trail that connects the State Park to the Corp of Engineer's property. Because the trail already exists the project is to connect the two by building a bridge over Bear Brook. To connect the two properties requires permission from Larry Gould to take a piece of his property for the bridge. Larry Gould has agreed to it. The new head of the Corp of Engineers is requiring an adequate legal document between Larry Gould, Townshend, and the Corp of Engineer to commit to build the bridge.

Charlie requests that the Selectboard works with Larry and the Corp to get the document finalized. Lake states that he would like a lawyer to review this and put together the document.

B). **Townshend Library Board Presentation:** Marilee Attley from the Library Board gives report: Mary Moberly generously bequeathed funds to the Townshend Library. The Library Board and staff are currently putting together a town survey for residents to give their thoughts on how the money could enhance the library's service to the town.

5). **Correspondence:** WSWM Workshop Letter: Executive Director of WSWM sent a letter thanking Eddie Benoit and Irv Stoll for attending their training.
