**5. Correspondence:** Lake reports that the Selectboard has received a letter from Ella Kinsman requesting that the Selectboard Agenda, Zoom Link, and Minutes be posted on Front Porch Forum. He raises his concern that a zoom link posted on an open forum that goes out beyond Townshend residents could invite zoom bombers. Wrights raises the issue that if BCTV is recording it why do we need to put out on Front Porch Forum. Felker raises that the zoom link is the same every week and is in the meeting warning. People know what the zoom link is. Lake concludes the discussion with an agreement from the Board to post the Agenda and the meeting minutes on Front Porch Forum.

1. Town Meeting: Lake reports that the VT State legislature has passed a bill to give towns the option to no conduct an in-person town meeting due to CoVid. Lake recommends doing Town Meeting like we did last year given the Covid rates in VT and Windham County. Wright states that he did not like Australian ballot and not having an in-person Town Meeting. Frisk states that he is in favor of holding an Australian ballot for one more year. David Liebow states that given the current rates of infection he thinks it makes to move to an Australian ballot. Dercoli makes a motion to hold a town informational meeting via zoom and live streaming and to conduct an Australian ballot vote. Frisk seconds the motion. Motion carries 4-1-0.
